





## Getting Paid Your Real Worth

Max Chargeable Hours per Year

To earn \$100,000

100,000 1000

To cover overheads

30,000

1000

\$100 + \$30

Total to be charged Plus 10% GST

= \$30 / hour

1000

= \$100 / hour

= \$130 / hour

= \$143 / hour

## Did You Get It Right?

You Charge \$143 per hour, but you only get 500 Chargeable Hours that Year

\$143 x 500

Less your overheads

**Less your GST** 

So you only get






